5	7/18/1982	6:30 PM	Dinner at McDonald's	Hank takes Tanya and Michelle to dinner at McDonalds
6	7/18/1982	7:00 PM	Hank takes Michelle home	Hank takes Michelle home to discover there was a break-in

12	7/19/1982	12:30 AM	Hank leaves drive in theater	After two movies completed Hank heads for brother's house
13	7/19/1982	1:00 AM	Hank arrives at brother's house	Hank arrives at brother's house where Teddy and Kenny watching TV
14	7/19/1982	7:00 AM	Hank wakes up	Hank wakes up and makes coffee
15	7/19 1982	8:30 AM	Hank arrives at Tanya's house	Hank to have discussion with Tanya's parents but goes to McDonald's

22	7/21/1982	10:00 AM	Mary Mahaney sees two girls	Mary Mahaney believes she saw Hank talking with Tanya & Michelle
23	7/21/1982	10:00 AM	Hank stops by Tanya's house	Roger Frappier sees Hank talking with Michelle & Tanya at Tanya's house
24	7/21/1982	2:30 PM	Daniel Mastroianni locates Hank	Daniel Mastroianni driving his Taxi cab locates Hank on 1st try
25	7/21/1982	3:00 PM	Hank arrested	Hank is arrested by W. Springfield police and taken to jail
